### General Rules and Regulations

- Please bring your own trash bags. Deposit all bagged trash in dumpster (no loose trash).
- Camp Denison is a drug-free and tobacco-free venue.
- Fishing is permitted at Camp Denison. A Massachusetts fishing license is required.
- The following are **prohibited** at all times: loud or disturbing behavior; intoxication or possession or use of illegal substances; non-permitted open fires; dumping or leaving trash or other materials anywhere on the property; destruction or marking of any Camp Denison properties, including buildings, benches, tables, signs, markers, trees, and vegetation; hunting; trapping; the possession or discharge of firearms; harassing or disturbance of wildlife; off-road motorized vehicles; swimming.

### Permitted Camping Areas:

- Adjacent to the Nature Center, near the fire pit
- Adjacent to the Herb Hubbard Pavilion (no fires permitted)
- Around Council Ring with fire pit
- Wooded area east of field
- Large field
- Bunkhouses/Cabins
- Tent platforms in cabin area

Once approved by Camp Manager, checks may be made out to “Town of Georgetown” and mailed to: Camp Denison, 84 Nelson St, Georgetown, MA 01833. A deposit or full payment, and a confirmed reservation is required prior to using the facilities. The Camp Denison Committee reserves the right to retain part or all of the reservation deposit if cancellation is made less than 30 days prior to scheduled use.
