TERMS OF AGREEMENT
FOR RENTAL OF Canoe / Kayak / Board (called the "boat") STORAGE SPACE
at Camp Denison Boat Launch

1. Fee for one rental space is \$100. Term of rental is April 1 to March 31. NO prorated rates available. Discount rate for Handicapped (with placard) and Seniors (60 and over) is \$75.00. Rental must be paid in full, with submission of this rental agreement, by March 15 prior to the new rental year.
2. Maximum length/width for the boat is 20'x 3'.
3. Rental is on a first come, first served basis, with renewals given priority until April 1, at which time rental space is forfeited if a waiting list exists. Agreement and funds must be received by the Camp by March 15 for renewal to be considered in effect.
4. Upon receipt of form and funds (check preferred), space will be assigned by number, before placement of boat is allowed.
5. Owner agrees to remove boat if **current** rental agreement is not in effect. Failure to remove boat from rental space if current rental agreement expires and thus is not in effect will result in removal of boat from space and possible forfeiture.
6. Owner must ensure the boat is reasonably secured in its assigned space and will not pose any danger to any passersby or other renters. Owner must provide locking mechanism.
7. Owner must ensure the rental space is always clean and orderly. Nothing other than one canoe or two kayaks or two boards can be left on the rack at any time. Any boats on the ground will be considered as discarded and removed from the storage area.
8. The storage space may only be used for the one canoe, or two kayaks, or two boards (if they fit in one space).
9. Owner acknowledges that boat storage rental is at their own risk. Camp Denison and the Town of Georgetown accept no responsibility for loss of or damage to the boat. Failure to comply with above terms will result in termination of this agreement and forfeiture of rental space with no refund of rental fees.

I agree to abide by the rules and regulations stated above and I hold myself solely responsible for any mishap/injury or damage to or loss of the boat(s) listed above.
